I/We the undersigned do hereby apply for a Criminal Bail Bond for the named person. I/We hereby agree to hold harmless the Surety Company, Red Stick General Agency and the Agent from any losses, attorney fees and any costs incurred by the Principal failing to appear in Court during the pending of any changes filed, or until the extinguishment of this bail undertaking. The Agent or Surety may enforce the provisions of this contract.

1. The Surety Company, its Agents, are hereby authorized to obtain credit information on the Defendant, Indemnitors or Guarantors to this Agreement.
2. The Surety Company, its Agents or Assigns, are authorized to pick up and surrender the Defendant to the appropriate jail or court, if any breach by Defendant or by orders or decrees of a court of law, enforcement authority, or any change in circumstances of Defendants release on bail to Surety.
3. Defendant shall not leave the Jurisdiction of the Court, without written authority of the Court and the Surety.
4. The premium paid for the bail undertaking is earned by the Surety upon presentation of the Surety's bail bond to the appropriate authority.
5. The Defendant and any and all indemnitors do hereby promise to pay any and all costs incurred of forfeiture, surrender, attorneys fees, hourly fees, bail amount, interest, and Court costs incurred as a result of any breach of this bail undertaking.
6. The Defendant and the Indemnitors understand and agree that all are jointly and individually liable for the full amount of the bond amount and any costs, fees, and interest, if the bail bond is forfeited by Defendant's non-appearance at any proceeding or court ordered rules and regulation.
